USING THIS EYEWEAR

The safety spectacle with transparent lenses and frame and main structure includes the lens, the nose holder, and the mirror foot. The main material is PC.

This spectacle meets the minimum requirements for eye protectors against EN ISO 16321:2022 and protection against high-speed particles at impact **level D**.

GENERAL INSTRUCTIONS

This spectacle can be worn all day in a normal working environment and this pair of spectacles should only be used at room temperature.

This product is not supplied with any accessories.

It is advised that you keep this spectacle in its protective bag or box when not in use.

It is advised that this spectacle should not be worn over prescription frames, as there is the possibility that impact may be transmitted to the prescription frame and thus create a hazard for wearer.

WARNING

Check the spectacle regularly for noticeable scratching, pitting or any other damage to the lens, scratching, pitting, or other damage to the lens can seriously reduce the level of impact protection provided by the product. Such product immediately be discarded and replaced.

No parts on this spectacle are replaceable or interchangeable.

Protectors that have been subject to impact shall not be used and shall be discarded and replaced.

If any part of the spectacle is deemed unfit for use, then the whole product should be discarded.

Materials which may come into contact with the wearer's skin could cause allergic reactions to susceptible individuals. The user should check for any such reaction and cease use of product if any reaction is observed.

Scratched or damaged oculars should be replaced.

This spectacle against high-speed particles worn over standard ophthalmic spectacles may transmit impacts, thus creating a hazard to the wearer.

Protectors that have been subject to impact shall not be used and shall be discarded and replaced.

This spectacle offers no protection against IR radiation and thus should not be used as primary protection in environments where dangerous levels of IR radiation are present, for example where welding operations are carried out or the casting of molten metal.

If the impact letter is not followed by the letter T, then the eye protector shall be used against high-speed particles at room temperature.

If the impact level symbols are not equal on both the lens/filter and the frame, then it is the lower level that shall be assigned to the complete protector.

The protections corresponding to the code numbers/letter 7, 9, CH are provided by the complete

protector only if the respective symbols are equal on both the lens and the frame.

STORAGE

Spectacles should be stored at temp above 5°C and below 40°C, RH, 90% and kept away from solvents, or solvent vapors or any corrosive materials, as these may seriously reduce the impact protection provided by the glasses.

Recommended product life is 2 to 5 years. Different factors can cause deterioration which can lead to shorter lifetime.

CLEANING AND DISINFECTION

This spectacle can be cleaned and disinfected with soap and lukewarm water. It is recommended that wiping of lens be kept to a minimum and only done with soft nonabrasive cloth.
